You and the Motor Vehicle nominated for registration are subject to disqualification without notice if, in the sole and unfettered discretion of AMCA, you, your motor vehicle, or crew, pose any threat to safety and/or the orderly conduct of motor racing events or if you are in breach of the AMCA rules.

DECLARATION OF APPLICANT

In this Declaration, a reference to AMCA, a promoter, organizer or sponsor, includes a reference to their respective duly authorized agents, employees, and officials (hereafter referred to as "AMCA Associates").

In consideration of AMCA's acceptance of this application, I agree to abide by AMCA'S rules (as amended from time to time) and any further regulations governing an event in which I am competing as a driver.

In addition, I agree as follows:

1. That neither AMCA nor its Associates warrants, whether expressly or by implication, that any services rendered by them, or on their behalf, will be rendered with due skill and care or that any materials provided in connection with services performed are fit for the purpose for which they are supplied;
2. To hereby release and forever discharge: AMCA; and any promoter, organizer or sponsor of a motor racing event in which I participate as an AMCA affiliate, from any liability whatsoever arising from my death, or personal injury, (including psychological trauma or nervous shock) or any loss and damage whatsoever and howsoever arising from my participation as a driver or attendance at a motor racing event.

3. That motor racing is an inherently dangerous activity. By reason of the nature of the motor sports, it is subject to risks of serious personal injury and death which can be caused in circumstances which may or may not be foreseeable. I acknowledge that I may suffer injury or death as a result of:
- Collision of motor vehicles (or parts of them) with other motor vehicles, persons or fixtures;
 - The unauthorized acts, inadvertence, omission or wilful negligence of scrutineers, officials, other contestants, crew engaged by other participants, or spectators.
 - The inadequacy of facilities (including spectator stands, guard rails, fences) to ensure the safety of persons or property at the event; or
 - Poor track or Pit conditions.
4. I accept that motor sports are dangerous and that accidents can and do happen and may happen to me. I accept that as a consequence, I may suffer injury or death. I indemnify AMCA and AMCA Associates from and against all liability of any nature whatsoever arising from injuries suffered or wrongful death which may occur, as a result of my participation as a contestant in a motor racing event.
5. I will abide by the directions given by AMCA officials at any motor racing event at which I am participating as an AMCA Affiliate;
6. I am over the age of 18 years, or 16 years and accompanied by a guardian.
7. I am the driver/owner of the above registered AMCA race car and I will be the recipient of payments (prize money and other) as a result of racing in events arranged by AMCA and will be participating in these motor racing activities on the following basis: (Please tick one of the following)
